

**Dear Parents,**

We are very pleased that you are planning to come to this year's Celebrate Life Festival. This year, too, we, the Transparents team ([www.transparents.net](http://www.transparents.net)), are responsible for the entire child care and youth support.

It is very important for us that we thereby practically implement some mystical principles in our contact with the children, such as bonding, the incarnation of a soul, the development of a child's potential and the respect for inner life rhythms.

We emphatically ask you to ensure that you give your children enough time to arrive safely and be received by the childcare workers and not leave until your children have arrived fully. For children aged 0 – 3 there will in the afternoons be a space of discovery that is accompanied by us, and we warmly invite you and your child to attend. Here, the important thing is to give our children our undivided attention and simply not do anything, except being present. You are also always welcome to the childrens' and JUKI tent to be with your child with this attitude of silent presence and simply be with him or her.

**Very important:** Please always pick up your children on time, even if what is happening in the tent is running late. It is simply not good if they have to wait once others have been picked up. Below you will find a few organizational questions that we ask you to answer and bring to the respective child care tent on the first day. We wish you a wonderful Festival and a heartfelt and inspiring time with your child/ren!

  - The children are not forced to stay at the camp.
  - This includes the free movement of the children on the whole ground of the festival, including the pond.
  - Everything happening in the pond is not our responsibility!
  - Parents are responsible for their children!
